

French Broad Food Co-op Board of Directors Application (revised 4/16)

To apply as a candidate for the FBFC Board of Directors (BOD) please read the following information to determine that you are able to meet the requirements. If you are able to fulfill all requirements of board service, print pages 2 and 3, then complete and sign an application, scan it, and email it to our board assistant: jean.karpen@fbfcboard.org. You will receive a confirmation email of receipt of your application within 5 business days.

You may send email inquiries to board@frenchbroadfood.coop if you have questions about the application or election process, as well as questions about board service. All applications will be reviewed and kept on file. If approved by the BOD, current applicants will be added to the ballot for the next election. Applications on file may also be used to appoint BOD members to fill vacancies between elections.

Duty of care and duty of loyalty are a part of the fiduciary responsibility of a BOD member. Duty of care encompasses consistent attendance at meetings and participating in events, being prepared for each meeting by reviewing all documents and protecting the board's process with integrity. Duty of loyalty is the responsibility to act on behalf of FBFC in the best interest of the cooperative and its members as a whole.

Members of the BOD must:

- Be a FBFC owner 'in good standing.'
- Have frequent, reliable access to phone and e-mail & read and respond to emails between meetings.
- Read and study co-op bylaws, policies, articles of incorporation, industry articles, information on the BOD's governance model, and other co-op related material.
- Attend monthly board meetings (currently 3rd Thursday of the month 5:30 - 8:00 pm), board development retreats (1-2 weekend days per year), workdays, educational seminars, special events, and occasional extra meetings in special or emergency situations.
- Serve on and possibly chair a BOD committee.
- Be able to commit to a term of 3 years.
- Work cooperatively with other BOD members to monitor, evaluate, and consult with the General Manager within the decision-making process of the Board.
- Uphold the duty of loyalty by disclosing potential conflicts of interest, not competing with the cooperative, and honoring confidentiality.
- Be 21 years of age or older.

You are welcome to attach a resume or CV and return it with application. All questions should be answered either through the resume or by adding additional pages if necessary. Feel free to add other pertinent information.
