Draft Minutes French Broad Food Coop Annual Owners' Meeting October 27, 2022

The meeting was held via Zoom due to the ongoing COVID 19 pandemic. The meeting began at 6:05. Twenty-four (24) owners attended; we did not have a quorum.

Welcome remarks and overview by Board President Adam Bowers

Board members present tonight briefly introduced themselves.

Adam reviewed the agenda for the meeting.

Minutes of the 2021 Annual Owners' Meeting were posted on the screen for all to read. Voting on approval of the minutes will take place along with Board elections.

Christa Hamilton explained the initiatives we have recently taken to make ownership and participation in the co-op more accessible:

- Made ownership more affordable by offering an alternative to the current structure of \$25.00 per year for 10 years. The alternative is \$12.50 per year payable over a 20-year period.
- In partnership with DUFB (Double Up Food Bucks), we are offering a scholarship to cover the annual ownership fee for every DUFB participant who would like to become a co-op owner. Scholarships will be funded by donations from co-op shoppers.

General Manager, Bobby Sullivan, gave a store review and update. The complete report is included after these meeting minutes.

Finance and Project Manager, Sage Turner, gave an update on our expansion project.

- Sage shared a slide presentation of the expansion work as it has progressed.
- We are currently finishing Phase two of the four-phase project. Phase two includes restoration, deferred maintenance, and replacement of large facilities and equipment new kitchen, new roof, new walk-in coolers, new freezer, insulation, central heating & air, structural repairs, stormwater. Phase two is scheduled to be completed in the next few months.
- Phase three includes a new building between the two existing buildings, creating one larger store. We plan to take a year to adjust to our new larger space, grow steadily, and begin planning for this phase.
- Phase four is mostly parking lots, landscaping, and final touches.
